DISCLAIMER OF THE LAUDATO SI FOUNDATION

The Sierra Norte is a beautiful place to walk and enjoy nature, but it has a very meager infrastructure to accommodate pilgrims and travelers who enter it. The work of the Laudato Si Foundation is to make a pleasant tour that, to our In a way of seeing, it has similarities with the literary work in question in natural landscapes. The preparation of this tour is concretized in the preparation of a "personalized guide for to walk the path of the Ring", which should be understood as an aid from which the traveler you must call the sites to make the reservation of the accommodations you will need. THE WORK of the Foundation is to serve as a bridge between the traveler and the establishment and guide him in the course of the route of the "Camino del Anillo". Likewise, the traveler can hire an "accompaniment" service that can have several levels as the traveler or pilgrim wants, it can be closer or totally far away letting the traveler do what he sees fit at all times. In either case, the "WAY OF THE RING" is a pilgrimage in which the traveler is responsible for the basic services it contracts. The Laudato Si Foundation exclusively provides the following services:

- 1.- Offers a personalized advisory service to be able to articulate the pilgrimage or walk in the Sierra Norte according to the client's instructions. Provide prior information on available accommodation and places where you can have breakfast, lunch and dinner. The Foundation Laudato do not own, manage, control, promote, manage or operate any transportation or recreational, motel, hotel, restaurant or any service provider of which appear in the report of the consultancy that the traveler hires him, with the exception of "The museum of the Tales of El Molar or interpretation center of the Camino del Anillo and the hostel of El Atazar of the street of the slope 23)
- 2.- Teach a course of a few hours before on the meaning of the pilgrimage, ecosystems (landscape, fauna and flora) that the traveler will find on his way as well as in the interpretation Tolkien who makes the foundation of these landscapes.
- 3.- Deliver some indicative tracks so that the traveler can travel their way every day customized to reach the points where it has been suggested to sleep, eat or enjoy of planned activities in the consultancy
- 4.- Teach a short course to know how to handle the tracks that are delivered to the client.
- 5.- Deliver the "pilgrim's guide" to the traveler in the initial course.
- 6.- If the traveler so wishes, he can have a personalized accompaniment service, which can range from a remote accompaniment to a personal and interpretive one.

Therefore, the Laudato Si Foundation is not responsible for:

- a.- Any accidents or losses in the mountains, hotels, restaurants or other places that you saw the traveler(s).
- b.- Any complaint that the traveler could have about accommodation, catering services, hotels
- c.- Any loss following the tracks, as these are merely indicative.
- d.- Nor is it responsible for the state of the roads, or even that these, in their steps mountain may not be visible due to abandonment of the same, or by loss of signals identifications that may appear in them, and that in no case are signs of "The Way of the Ring."

e.- Nor is it responsible for any altercation that may happen with wild animals or domestic. The Camino is limited to strongly begging that pets not be taken to it, and in case of wearing them, it asks the traveler to always carry it tied with a leash as required by the legislation in force, being fully responsible for any incident or demand that the owner of the pet may suffer from ranchers or farmers in the area because of the behavior of your pet. The Laudato Si Foundation will not be responsible in any case of incidents with dogs (especially mastiffs), cattle or wolves that may cause the traveler's pet. The traveler who is warned of do not take a pet on your trip and remind you of the stress that a dog can generate in livestock who is subjected to wolf attacks.

Likewise, the Laudato Si Foundation will never be responsible for:

The preparation of travelers: The organization has nothing to do with the physical form that travelers or pilgrims must have to do the different stages, although we ask that have seen the distance of them, their difficulty and that they take place in nature. The Traveler should not risk doing stages with adverse weather of any kind without before looking at weather forecasts and risk alerts in the area. If you do, it is at your own expense and risk.

Information: The traveler or pilgrim must have all the information about the accommodations that they are going to hire the form of payment, stays, etc. The Foundation will have offered you a previous consulting, but any changes or setbacks that occur will never be responsibility of the Foundation. The "personalized guide of the Camino" does not exempt the responsibility to call, agree and check with each service that will be contracted along the way.

Travelers or pilgrims: You must have read all our indications of where and how reserve Reservations: The organization will not be responsible for booking errors attributable to the traveler or that are caused by unavoidable and extraordinary circumstances or that are due to the Accommodation. In no case are we a travel agency, just a facilitator of services and information on how to travel The Way of the Ring. We do not take care of the accommodations or the price, nor its variations. If ancillary services, such as the transport of backpacks, these will be paid separately in case we commit to do. Loss of or damage occurring in connection with carry-on baggage or other objects that the traveler carries with him will be of his exclusive account and risk while they are under the custody of the traveler. Special diets (vegetarian or special regimens) are raised in the guide but must be checked and agreed and purchased from suppliers of food. It will not be the responsibility of the Laudato Si Foundation, if the agreement is not fulfilled between the traveler and the food supplier.

Insurance: We urge pilgrim travelers to take out travel insurance, especially if not belong to the European Union. In no case will the Foundation be responsible for the costs that arise from cancellations of reservations, hotels, planes, meals for any reason, including Pandemics.
